9. NORTH LINCOLNSHIRE COUNCIL MATTERS

i. Parking and traffic flow problems – Front Street – a site visit was held which a number of parish councillors attended with Ian Jickells(NLC) and Ferry Ward Councillors. The contractors working at hallcroft have been asked to park more appropriately in order to allow traffic to negotiate Front Street safely and N.L.C have written to residents in this area asking them for their views on extending the double yellow lines around the corner near the electricity sub station, covering the hallcroft junction up to the point just beyond the business court access. Views are required by 13th April 2016. The Chairman thanked the ward Councillors for their help with this matter.

ii. New N.L.C highways matters – The STOP sign at the Abbey Road junction needs urgent attention- corroded and unsafe.

As you enter Abbey Road from High Street the road appears to be sinking and could be very dangerous for motorcyclists/cyclists.
