- a) Snicket West End Road, Ulceby N.L.C do not feel that this snicket needs any attention. Cllr Jeffery feels N.L.C may have inspected it when it was dry but after rain it has numerous potholes. Clerk to try and meet a representative from N.L.C at the lane to reinspect.
- b) Drainage matters throughout the village some work has commenced on Front Street and drains for Coronation Road. A drain needs jetting out on Front Street outside the toe new Keigar properties the problem in this vicinity has obviously not been cured and problems have been reported on Carr Road the culvert outside property known as Burtonswood needs cleaning out it is full of silt. Properties on Station Road have had their gardens flooded at the rear and some feared their property would flood as the drainage on the Station Road field (N.L.C owned) has not been addressed. Cllr Clark agreed to take these matters forward to Rod Chapman at N.L.C.
- c) West End Road this overgrown footpath has been reported to N.L.C.
- d) Bin Thornton lane overflowing this has been reported to N.L.C and subsequently emptied.
- e) Bus Service N.L.C ward members have been made aware of the connection problems with various buses serving this area who have agreed to ensure the bus company is made aware. The meeting was advised to try and make full use of the 'Callconnect' service whenever possible as this is a service which needs to be successful in this area.
