PUBLIC FORUM

- A member of the public expressed concern regarding the drainage issues –
 particularly with foul water drainage on Abbey Road.
- A member of the public expressed concerns regarding Ulceby being the diversion route when the A180 is closed due to an accident. On 21st December the whole village was gridlocked for a considerable time. The local MP Martin Vickers has been advised of the problem. It was noted that Ulceby is the designated diversion route as it is an 'A' road however Cllr Hannigan agreed to investigate if there are any alternatives to Ulceby being the sole diversion route.
- A member of the public advised the meeting that he felt that regular services
 for Ulceby road sweeping, footpath cleaning, bin emptying were
 infrequent and Ulceby appeared to have a 'lesser' service than other towns and
 villages in North Lincolnshire. Cllr Hannigan advised the meeting that these
 services were programmed and followed a rota so all villages received a
 similar service.
- A member of the public advised the meeting that he felt that Anglian Water should be held accountable for the poor drainage both sewerage and surface water in the village of Ulceby.
- A member of the public asked the parish council to reconsider their decision regarding a statement piece as the preferred choice for the north Lincs in Bloom funding. He felt that a series of flower beds/arrangements throughout the village would be more appropriate.

Opportunity for one person from each side (members of the public) to state within three minutes objections/support of contested application.

A representative of Keigar Homes addressed the council to provide further information on the two applications 9a) and (b). The main cause of concern for the councillors was the arrangements for surface water and foul drainage. An explanation of how all the water was to be kept on site was provided and a statement from Anglian Water was provided who have indicated that they feel the drainage provision to be provided on these sites would be adequate.

- c) Application PA/2017/1950 Advertisement consent to retain one fascia sign and one projecting sign Sun Lee, Ulceby Chippy, High Street, Ulceby. IT WAS RESOLVED to report NO OBJECTIONS OR COMMENTS.
- d) Application PA/2017/2017 Planning permission to erect a detached dwelling and detached garage Land adjacent to Coates Farm, Station Road, Ulceby. IT WAS RESOLVED to report NO OBJECTIONS OR COMMENTS.
- e) Application PA/2017/1860 Application for none material amendment to PA/2015/0312 adjust internal floor area of convenience store and back of house(overall building size not increased), adjust position of rear fire exit door, adjustment to entrance door position, adjustment to window mullion position within top light and new landscaping scheme The Brocklesby Ox, High Street, Ulceby.

It was agreed that a new Union Flag would be appropriate – clerk to provide a quotation for a suitable flag for the next meeting.

v) To give consideration to the grass mowing contract for 2018: The clerk provided the information for the grass mowing costs for the next mowing season (2018).

IT WAS RESOLVED to accept the terms provided by Barton Mowing Services.

i. Reports from N.L.C representatives – Cllr Clark advised the meeting that he had spoken to the clerk to arrange for Matt Moore to attend this pc meeting to discuss the drainage plans for the village of Ulceby. Matt Moore has not responded to the clerks email requests to attend this meeting.

Cllr Hannigan offered to get a clear report / position statement from N.L.C drainage team and Anglian Water on what exactly the plans for Abbey Road drainage improvements are and a time scale.
