11. ENVIRONMENTAL AND VILLAGE ISSUES

- a) Parish Pump area progress has been made with this matter the power suppliers will isolate the power on 12/4/18 so the Silver birch branch can be pruned. The rest of this area has been pruned and tidied.
- b) Seat and salt bin opposite the co-op store. The seat has been ordered. The clerk has written to the co-op store requesting a donation towards a new salt bin for this area.
- c) New matters to report Dog fouling is again a problem throughout the village. The dog warden can attend but they need specific times and even names/addresses of those responsible.

The drain at the new pavement area adjacent the shop isn't functioning properly and needs jetting. The drains throughout the village require this treatment.

Flytipping is evident on Crossroad – near the farm track entrance and litter is evident from this farm track to Glebe Farm.

A discussion took place regarding a weight limit through the village but it was noted as it is an 'A' road this will not be considered by N.L.C.
