2018/19 - 08 A meeting of Ulceby Parish Council was held on Monday 18th June 2018 at 7.00pm in The Village Hall.

PUBLIC FORUM

Members of the public attended the meeting to express their disappointment that the bus service had changed from Hornsby's to Stagecoach. Cllr Hannigan advised the meeting that the service had been put out to tender and Stagecoach was the company who were successful in this tendering process. Presently there is a bus service to Brigg on a Tuesday, Thursday and Saturday and the bus will pick up at various points through the village. The new service commencing 2nd July will not pick up through various points in the village – just at the railway station and the post office and the Saturday service is ceasing.

A discussion took place regarding using a dedicated 'Callconnect' service on Saturday to take residents in Ulceby to Brigg. Cllr Hannigan was happy to arrange this service, however a resident had already commenced discussions with 'Callconnect' and it was agreed that this resident would continue to make arrangements for this service but would contact Cllr Hannigan if any difficulties arose.

A member of the public advised the Ward councillors that the 'callconnect' service was a good service but was in danger of being too busy and therefore unable to provide the service residents required. Cllr Hannigan noted this fact.

A member of the public advised the meeting that he had been in touch with Anglian Water – and eventually was able to talk to a representative of Anglian Water – regarding progress being made with the sewerage drainage problem in Abbey Road. Anglian Water have agreed to undertake a survey/camera investigation and report their findings before the end of June.

The meeting reminded ward Councillors that Anglian Water had promised to commence work on Coronation Road before the end of the last financial year – March 18. This work has not commenced – Cllr Clark/Hannigan agreed to speak to Rod

Chapman at N.L.C and request an update on this matter. It was noted that a diversion from the A180 had been put in place last week and the new diversion route through Brocklesby Park had been instigated however HGV traffic was still diverting through the village of Ulceby. The resident suggested to the Ferry Ward Councillors that a weight restriction in Ulceby should be considered and this is likely to have the support of Wootton and Thornton Curtis parish council. Cllr

Hannigan suggested that he arrange a meeting with Ian Jickells and Roy Hindmarsh of N.L.C with himself and the member of the public to discuss the best possible diversion routes and the possibility of a weight restriction in Ulceby. Cllr Hannigan will arrange this meeting.
