A meeting of Ulceby Parish Council was held on Monday 16th July 2018 at 7.00pm in The Village Hall.

PUBLIC FORUM

Two representatives of Anglian Water – Matt Moore and Gavin Stanley – attended the meeting to provide information about the proposed works planned for Ulceby. Work is planned for Abbey Road, Coronation Road and a main DG5 scheme is also planned.

Work is planned to two specific properties in Abbey Road where when there is an overload of surface water the sewerage drainage is adversely affected. Once this DG5 scheme is complete all the return valves, already fitted in properties, can be removed as they will not be necessary. The DG5 scheme will provide 2 major construction products to alleviate the sewerage problems – at the sewerage works at the end of Thornton lane an extra holding drain and storm lagoon will be provided and this work is planned between April – September 2019. Anglian Water are also making arrangements to ensure all odours and smells are eliminated too.

Four properties on Coronation Road are adversely when there is heavy rainfall. N.L.C are undertaking a programme of works to improve surface water drainage and Anglian Water are also contributing to this programme of works.

The Chairperson welcomed new councillors – Tony Ogden and Andy Reeve to their first parish council meeting.

- a) Footpath – Church to West End Road and Vale Farm – both these public footpaths are the responsibility of N.L.C who have indicated that the required repairs and mowing will take place in due course.
- b) Water Leak – High Street, Ulceby – this leak has been reported once again by the clerk and members of the public. Anglian Water are aware.
- c) Road repairs – Hallcroft/School Mews, Potholes Abbey Road and Priory Crescent – all reported and N.L.C have confirmed that job tickets have been issued for this work. Some work on Abbey Road has been undertaken.

8. POLICE MATTERS:

- NATS meeting – Cllr Mrs Caygill-Ogden attended the meeting with Humberside Police and Crime Commissioner on Tuesday 26th June 2018. The Crime Commissioner indicated that he would be prepared to attend a parish council meeting. Clerks note: From another parish council meeting it was noted that the police will react more quickly and will prioritise matters which are reported through the NATS system. Obviously emergencies should still be reported to 999 or 101.
- New Police matters – It was reported that vandalism and damage is occurring to cars parked within the village.

10. NORTH LINCOLNSHIRE COUNCIL MATTERS

- i. Reports from N.L.C representatives – Cllr Clark reported on a meeting held at N.L.C with highways officers, resident Mr S Smith, Cllr Hannigan and Cllr Clark regarding HGV movements through the village. N.L.C have agreed to monitor HGV movements through the village ('Golden Rivers') have already been laid in the village to collect traffic movement data. This data will be analyzed which will then allow N.L.C to make decisions regarding the control of traffic through the village. A weight limit for Ulceby was discussed but this will not be progressed until all other options have been considered. A reduction in the speed limit from Skitter Hill, over the level crossing and to the truckstop was also discussed and will be considered when the traffic data has been analyzed. New signs at the truckstop – directing HGV's back onto the motorway network rather than through the village of Ulceby will be progressed once a planning application by the truckstop has been considered.
- ii. Diversion route for A180 closure – It was noted at the meeting that additional and clear signing needs to be in place to ensure all drivers recognize that the new diversion route is through Habrough and Brocklesby Park and not through Ulceby.
- iii. New N.L.C highways matters – Cllr Rowland suggested that signs need to be back in place at the crossroads in Ulceby (they were removed when building work was taking place at the old church/chapel and not replaced by N.L.C).

Drivers from Brocklesby direction do not realise that they need to turn left to go to Barton – there are no signs indication this and therefore travel straight on down Abbey Road.

11. ENVIRONMENTAL AND VILLAGE ISSUES

- a) Salt bin opposite the co-op store - no response from co-op store regarding donation towards the salt bin as yet. The council may have to consider purchasing a salt bin later in the year.
- b) Seat – opposite new co-op store - the seat has now been fitted.
- c) Post Box – cleaning and painting – no response from Royal Mail.
- d) Road Gullies/road sides – the sweeper has been through the village in the last week.
- e) New matters to report – The debibrilator has been fitted to the village hall and the village hall will be able to accommodate approximately 15 cars for parking when the Coronation Road drainage works commence.
Road signs on Skitter Hill are obscured by hedge growth – clerk to try and arrange for them to be cleared. The public footpath sign at the bottom of green lane (opposite Carr Road) has been defaced – clerk to ask N.L.C to clean or replace. A hedge at a property on Abbey Road needs cutting back as it is infringing the pavement. The drains in the side of the road on High Street need jetting out and clearing of debris.
