A meeting of Ulceby Parish Council was held on Monday 18th February 2019 at 7.00pm in The Village Hall.

Welcome to Claire Welford – Engagement Officer Humberside Police and Crime Commissioner - North Lincolnshire.

Claire advised the meeting that her role and that of the Police and Crime Commissioner (Keith Hunter) is to be the voice of the people to the police. They endeavour to provide the services the public require from the police force and ensure that crime and community issues are resolved. They work with other agencies and services – NATS, safer neighbourhoods etc to try and promote a joined up service. Keith Hunter is particularly passionate about Local and neighbourhood policing. The queue buster for the 101 service is now resolved – this is a service which puts you in a queue and rings you back and is deemed to be one of the best services in the country. It is hoped that Humberside Police force can maintain the 1900 police officers and recruiting is on-going.

Claire advised the meeting that anyone not happy with the service they have received (or not received) from the police should contact her and she will follow up why the service was not as the public expected.

The police precept increase this year is likely to be 11/12% - which is necessary to maintain the jobs of 1900 police officers.

The chairman thanked Claire Welford for attending the meeting.

PUBLIC FORUM

- 1. A member of the public asked if there was an update from N.L.C on the distribution of 106 money no response received Cllr Clark agreed to follow up with N.L.C.
- 2. Church lane/Manor House development a building known as building D appears to have been demolished which did not form part of the planning application clerk agreed to investigate and report back at the next meeting.
 - 3. Dumper trucks appear to be using the highway to service the Coronation Road drainage scheme and these vehicles do not appear to have a licence plate. Clerk to investigate and report back at the next meeting.
- 4. A member of the public asked if cuts are planned to the 450 bus service N.L.C Ferry ward Councillors advised that no cuts are planned but this service is being reviewed as it is a very expensive service and the intention is to improve the callconnect service. A community bus service is also being investigated.
- 5. Link Magazine there are a lack of volunteers to deliver this magazine 2 more volunteers and a standby person are required. The meeting agreed to try and resolve this matter at the next meeting.

IT WAS RESOLVED to accept the quotation from Nettleton Mowing and Maintenance for April 2019 – March 2020.

8. POLICE MATTERS:

- NATS meeting Next meeting scheduled for 4th April In South Killingholme village hall.
- New Police matters It was noted that thefts have been taking place from gardens and a white transit van is a suspicious vehicle – number plates are required.

9. NORTH LINCOLNSHIRE COUNCIL MATTERS

- i. Reports from N.L.C representatives Cllr Wells advised that the 20mph flashing school crossing lights will be erected this week. There is an App for your phone which advises you if the stagecoach bus service is running late or delayed.
- ii. A180 Road closure/diversion route for A180 closure/village weight limit update on petition Cllr Hannigan advised the meeting that the report from the petition hearing from officers and the panel had been circulated today and it concluded that a weight limit will not be installed in Ulceby. Some of he reasons for refusal of a weight limit in the village were that the diversion route was deemed to be more dangerous that through the village of Ulceby, the accident rate in Ulceby is very low and that a weight limit in the village would not be policed by Humberside Police. The outcome of the petition hearing cannot be challenged. Cllr Hannigan advised the meeting that he would push for a 30mph limit through the village, into Ulceby Skitter to the level crossing.

Cllr Birtle advised the meeting that he felt that some of the data used by N.L.C to support the view that a weight limit was not necessary, was inaccurate, some representations were irrelevant and some questions were not appropriately responded to and therefore the 'no right to appeal' to the petition hearing conclusion was very frustrating. Cllr Birtle advised the meeting that the petition group were very disappointed with the panels decision but would comprehensively read the report from N.L.C and decide upon their next course of action.

Cllr Hannigan advised the meeting that the A180 diversion route was still in consultation but he was hopeful that the diversion route for both planned and emergency closures of the A180 could avoid Ulceby.

- iii. Coronation Road drainage work update on information provided by Anglian water with regard to sewerage drainage on Coronation Road and Abbey Road. The works on Coronation Road are progressing and the sewerage drainage work for Abbey Road and Coronation Road will be linked in appropriately with the current drainage works.
- iv. Directional signage at Ulceby crossroads to approve proposals for signs provided by N.L.C in this area and to discuss the removal of the barriers and confirm response to N.L.C.
 - The meeting agreed that they would prefer the pedestrian barriers to remain and to ask N.L.C to place the new signs on the existing barriers rather than removing the barriers.
 - v. New N.L.C matters: The condition of the road surface on Station Road all the way to Ulceby Skitter is very poor and needs resurfacing and repair. The bins in the lay-bys on the A180 need emptying more frequently as they are always overflowing.

11. ENVIRONMENTAL AND VILLAGE ISSUES

- a) To give consideration to moving the two flower troughs at West End Road (near the village sign) and replace at Halmshaws corner approval from N.L.C highways department has been granted. It was suggested that concrete posts be used clerk will talk to gardener to explore possibilities.
- It was agreed that these planters should be moved in time for summer planting. b) Community grant for winter bedding – to advise of a grant allocation of £450.00
 - which must be claimed by 08/03/2019
 The meeting was advised that the clerk has claimed for this grant.
- c) New matters to report: The lamp post outside Hillgarth Farm has been hit by a car and is badly damaged and no longer working. Clerk to report on the portal system. The clerk distributed the election papers and explained the election procedure.
 - The clerk has received a request from an elderly resident for a green salt bin to be positioned on the bank at Friarsgate N.L.C have quoted £250 +vat and £50 for a refill. This will be an agenda item next month to formalise the purchase of a salt bin for next winter.
 - It was noted that Ulceby PC does have an emergency plan which is stored electronically and can be updated.
