PUBLIC FORUM

Three members of the public advised the parish council on the following matters:

- a) Hallcroft to Church Lane overgrown nettles which need strimming/cutting back
- b) The bus stop area and the war memorial over grown hedge infringing this area
- c) The seat on Church lane will need removing due to the impending development work. Clerk to ask Keigar Homes if they will remove and resite at Carr Road junction near the notice board.
- d) The benches and War memorial need painting this will be an agenda item to discuss next month.
- e) All the footpaths around the village are overgrown and need scraping back.
- f) There is a very bad foul sewerage smell on Abbey Road Cllr Burdin has been dealing with Anglian Water over this matter and will continue to do so until the problem is resolved. Clerk to write to Anglian Water to reiterate the problem.
- g) Abbey Road still needs resurfacing Anglian Water advise they have no major works planned and therefore the road could be resurfaced.
- h) The road markings at the school still haven't been done construction work is taking place along Church lane which may have delayed this work being undertaken by N.L.C.
- i) Fly-tipping in the alleyway behind properties on Station Road . The alley/fortyfoot belongs to ONGO clerk to report the flytipping in this area.

3. ADOPTION OF THE MINUTES OF THE MONTHLY PARISH COUNCILMEETING HELD ON 17th JUNE amd 15th JULY 2019. IT WAS RESOLVED that the minutes of the parish council meetings held on 17th June and 15th July 2019 be confirmed as a correct record and signed by the Chairman.

4. MATTERS ARISING FROM THE MINUTES OF THE PARISH COUNCIL MEETING HELD ON 17th JUNE 2019.

- a) Name Plate signs Church Lane and Model Farm ordered.
- b) Public Footpaths cutting and maintenance Clerk has spoken to Colin Wilkinson and has checked the various public footpaths in the village. N.L.C have acknowledged that they have been very late in cutting the paths most now appear to be cut well enough to be passable apart from the path at Vale Farm. Clerk to continue to discuss the public footpaths with Colin Wilkinson including the repairs/maintenance of the path leading from West End Road to the Church.

- c) Overgrown Hedge Spruce lane this has been cut back.
- d) Community Speed watch initiative Ulceby have not been guaranteed a place on this scheme as yet it will depend if suitable locations which do not interfere with the Safer Roads Humber enforcement site on A1077 West End Road can be found. The clerk has sent through the following locations for consideration Martins Road/James Place on Station Road and Brocklesby Road. If it is thought that the operation of the community speed watch would detract from the enforcement operation of Safer Roads Humber then it won't be allowed. However the above locations are being considered. In preparation for a successful outcome of the above the clerk asked for volunteers to be considered to be trained for this scheme in readiness for Ulceby being accepted. There is an Ulceby road safety group meeting with N.L.C scheduled for 13/9/19 and this will be an agenda item for discussion.

6. PLANNING

IT WAS RESOLVED to SUPPORT this planning application

b) PA/2019/1156 – Planning application to vary condition 3 of PA/2019/759 namely increase the construction and site clearance working hours – Land off Thornton lane, Ulceby.

IT WAS RESOLVED to report NO OBJECTIONS OR COMMENTS.

- c) PA/2019/1253 Outline planning permission to erect a detached dwelling with all matters reserved for subsequent approval Land rear of Tythe Cottage, West End Road, Ulceby.
 - **IT WAS RESOLVED** to **OBJECT** to this planning application due to highway safety concerns the access being in close proximity to a junction.
- d) S106 payments to agree projects for Ulceby Parish to be submitted to N.L.C planning department which may benefit from any future S106 payments. Suggestions of a walking track and outdoor gym equipment were raised. There was also a discussion regarding better use of the old clinic building situated within the school grounds however it was recognised that there may be a safeguarding issue associated with the use of this building. This matter will be discussed again at the next pc meeting.

8. POLICE MATTERS:

- NATS meeting No report to receive.
- New Police matters There is an off road motorbike continually driving along Station Road.

9. NORTH LINCOLNSHIRE COUNCIL MATTERS

- Reports from N.L.C representatives Cllr Wells advised the meeting he will chase up the outstanding school road markings and believes that Abbey road is scheduled to be resurfaced after all the Anglian Water works have been completed. Cllr Wells also advised the meeting that he felt that the Barton / Barrow bypass would go ahead.
- A180 Road closure/diversion route for A180 /village weight limit- S Smith provided information from Highways England on their findings/results of the consultation with N.L.C, N.E.L.C and Humberside Police on the review of the diversional route for unplanned events (DRUE) which currently goes through Ulceby when the A180 is closed. Unfortunately Humberside Police and Highways England's operations manager don't support a change to the DRUE and believe that the route through Ulceby is the most appropriate route. Therefore Highways England will not be pursuing an alternative route.

S Smith advised the meeting that he feels that N.L.C should revisit this matter as the safety aspects of the residents of Ulceby have not been taken into consideration and no consultation has been taken with Ulceby residents or the Ulceby road safety group which would have informed Highways England of the many 'near miss' accidents, the pollution, damage to properties and environmental concerns associated with the DRUE through Ulceby. The fact that 2 HGV's cannot actually pass side by side at one section of the village has also not been taken into consideration.

The meeting agreed that if Highways England had agreed to send half the diverted traffic through Ulceby and half through the Habrough route this would have alleviated the problem in Ulceby considerably and would have been an acceptable compromise. This would have also allowed emergency vehicles to access the village when a DRUE was instigated. The clerk was asked to request a copy of the risk assessment indicating how emergency vehicles will access Ulceby during a diversion period. The clerk was asked to write to Highways England – advising that the reasons for not diverting traffic through Habrough are noted – but request that they give further consideration to splitting the traffic along the two routes as indicated above. Ulceby residents strongly feel that Ulceby should not take all the hardship and risk from excess traffic when s DRUE id instigated – the load should be shared. The clerk was also asked to try and obtain a set of minutes relating to the DRUE review which would provide the information as to why Humberside Police and N.L.C believe that the correct diversion route is through Ulceby.

Cllr Hannigan has agreed to meet with Humberside Police to try and get a Police presence in the village when these diversions are taking place to help the flow of trafic through the village.

11. ENVIRONMENTAL AND VILLAGE ISSUES

a) New matters to report: A resident has contacted Ward Councillors, North Lincolnshire Council and the parish council about the possibility of turning the N.L.C owned field on Station Road into a wild flower meadow. Cllr Hannigan has made enquiries with N.L.C about their intentions for this field and N.L.C have indicated that this field is to be included in the land for development proposal which comes out for consultation in September. Cllr Hannigan indicated that he would support the proposal for this field to be a wild flower meadow. It was also suggested that this field could be a recreational field for the village incorporating the wild flower meadow but also housing for example the adult gym equipment which a number of residents have expressed a desire for.

Cllr Hulatt indicated that the Post Box – situated in the lay-by – looks shabby – the meeting was informed that it is due to be painted in 2020.

The clerk was asked to make enquiries if a new post box could be situated adjacent the shop on the corner of Church lane – where the seat and salt bin is situated. It was reported that many curbsides – particularly Brocklesby Road, have an abundance of weed growth. Clerk to report to N.L.C.
