b) Community Speed watch initiative – Wayne Goodwin – coordinator of the community

speed watch programme has advised that any villages with speed enforcement sites

are not eligible for the community speed watch programme.

The clerk was asked to make enquiries to Richard Hall of N.L.C if the speed enforcement can be moved to a better location than Westfield Road – possibly centre of the village – if this is not possible clerk to try and establish the reasons why the location cannot be moved.

- c) Highways issues: Cllr Hannigan has ensured that if both carriageways of the A180 are closed traffic will be diverted along two diversion routes i.e only one way through Ulceby. If only one carriageway is closed the diversion route will remain through Ulceby. The Truckstop has agreed to try and encourage all HGV's leaving their site to tun right back onto the motorway network and not cut through the village of Ulceby.
- d) New N.L.C matters: Cllr Birtle provided a list of all the outstanding highways issues concerning Ulceby and asked that these matters to forwarded on to Lisa Coates of N.L.C to provide an update on these matters.
