  - v) Name of development off front Street, Ulceby – To confirm that the parish council's choice of name is Coxes Meadow.

To discuss how this S106 money is to be spent (outdoor play/recreation only) and to decide if the parish council is to contribute to the new play area at the village hall or pursue an adult outdoor gym trail – subject to village hall permission – or to suggest to the village hall - if it is feasible (with extra grant money) - that both ventures could be pursued.
