A 'zoom' meeting of Ulceby Parish Council was held on Monday 17<sup>th</sup> August 2020 at 7.00pm.

#### **PUBLIC FORUM**

Email from resident with the following items:

Query regarding the re-opening of the footpath from Hallcroft to Church lane – clerk advises that this has been given permission to remain closed until all the works are complete.

Bench on Church Lane – this has been removed but not yet resituated – resident suggests that it should be resituated to the west side of Martins Road to give rail travellers somewhere to take a rest.

The 450 bus service is being reviewed again and looks likely to have its service reduced. The hedge at Mount House has become overgrown – clerks note – this hedge now appears to have been cut back.

The member of the public present advised that he would email Cllr Mrs Caygill-Ogden for matters he would like raised at the next NATS meeting.

#### 7. Police Matters:

- a) Community speed watch and Safer Roads Humber speed monitoring: training can commence the village hall is now open to take bookings clerk is liaising with volunteers to ask when they are available for training and try to arrange a suitable date.
- b) Speed Enforcement in the village see Item 4(b).

Cllr M Birtle asked if the 'golden rivers' would be rolled out into villages again soon (speed and volume of traffic monitoring) – clerk to enquire if N.L.C/Safer Roads Humber feel that traffic levels have returned to normal after Covid and that traffic monitoring can recommence.

## 8. North Lincolnshire Council Matters:

- a) Reports from N.L.C representatives Cllr Wells advised that the speed enforcement site list is only reassessed and updated annually in April.
- b) Road Safety Issues: To discuss and agree the location of a pedestrian crossing in Ulceby.

The clerk outlined the matters for discussion regarding the request for pedestrian crossing(s) in Ulceby. There are two proposals – one crossing along Station Road to aid the residents of the new development of 90 houses cross and the possibility of a pedestrian crossing at the old co-op site (it would be necessary to move the bus stop and lay-by). Cllr Hannigan asked the meeting to consider if ideally they would like both of these crossings or just one – and if one, which is the preferred location. There was a discussion regarding the possibility of a crossing on Station Road being provided as part of the planning conditions for the 90 house development. Cllr Hannigan advised that he

would investigate if a crossing did form part of the planning conditions for this planning permission.

Cllr Wells suggested a crossing on High Street, close to Church lane – however the meeting felt that 'Halmshaws' corner would limit visibility for a crossing in this area. Cllr Rowland suggested that the crossing on Station Road should be an uncontrolled 'raised' crossing which would help slow traffic down travelling through the village. Cllr Jeffery proposed the following plan for the village of Ulceby:

i) A controlled crossing close to the old co-op site ii) An uncontrolled 'raised' crossing on Station Road iii) The lolly pop lady be retained to supervise a crossing on Front Street for the school children accessing school through Hallcroft along the public footpath. This proposal was seconded by Cllr Rowland and unanimously agreed.

The clerk was asked to write to Ian Jickells at N.L.C highways/traffic department advising of the parish councils request regarding pedestrian crossings in the village.

## 10. Environmental and Village issues

- a) Parish Pump area(Coronation Road) Still waiting for Nettleton mowing to provide a quotation
- b) \$106 funding report on meeting held with Ulceby Village Assoc Cllr S Hulatt advised the meeting that the clerk attended a meeting of the village hall association to discuss the possibility of a adult gym trail at the village hall. The village hall are happy to consider this proposal but would like to see if they get all the funding they have applied for, for the children's play area first. If they are successful they would be happy to try and incorporate an adult gym trail in the village hall grounds – subject to the parish council being responsible for the maintenance, upkeep, insurance and provide a contribution to the extra litter picking which may be required. If the village hall assoc, is not successful in their funding applications for the children's play area they may need some assistance from the parish council – the S106 money – to finalise their play area. The meeting agreed that the S106 money should be spent in the village whether it be on the children's play area or the adult gym trail. The clerk suggested that she make enquiries into how this S106 money can be secured for the village whilst the two projects are being progressed and funding for the children's play area is confirmed.
- c) Flower baskets for the 2 village signs Brocklesby Road and Skitter It was agreed that it would be nice to decorate the final two village signs with flower baskets but would be sensible to leave this until next year now.

d) New matters to report:

Angling Club at the village pond – clerk has received an email from a resident who is keen to set up an angling school and club at the village pond for children. Insurance for this club would be £62.00 and the parish council has been asked if they will support this club and provide some funding whilst the club gets up and running and eventually self funding. The meeting agreed that they were happy to support such a club (with one objection noted) but would require further information and confirmation that the village hall is supportive of this club. Cllr Hulatt advised that it was time to prepare another edition of the link magazine. A September issue will be prepared and hopefully a Christmas edition will follow – subject to there being sufficient material. Cllr Burdin offered to write an article on cycling and the governments promotion of this activity and it was suggested that the gentleman who is hoping to organise the fishing club write an article promoting the club.

Articles for inclusion within the link are required by 15<sup>th</sup> September. The developer of the properties behind the co-op has asked that the parish council considers a name for this new housing development. The developer suggested that the 'Brocklesby Ox' name should be retained for historical interest. The meeting suggested Brocklesby Ox Rise.
