1. **Apologies for absence :** Cllr D Johnson, Cllr C Rowland, Cllr P Clark, Cllr Wells.
2. **Declaration of Interest on any Agenda Items :** No matters to declare.
3. **Adoption of the minutes of the Annual Council Meeting and Monthly Parish Council meeting held on 15th May 2023.**
IT WAS RESOLVED that the minutes of the annual parish council meeting and the monthly parish council meeting held on 15th May 2023 be confirmed as a correct record and signed by the Chairman.
4. **To give consideration to the application for co-option to the parish council:**
 - **Mark Berney****IT WAS RESOLVED** unanimously to co-opt Mark Berney onto the parish council.
5. **Clerks Updates:**
 - Replacement litter bin – Abbey Road – N.L.C have secured the funding for new bins and a schedule/time scale to replace bins is being confirmed.
 - Signs – Crossroad – reported to N.L.C who have confirmed they will be repaired in due course
 - Hedge – Front Street – N.L.C have agreed to inspect. It was noted that it may have been trimmed back a little bit but the pavement is still only passable singularly and not with a pram or mobility scooter. Clerk to ask the enforcement team to revisit.
 - Built For Living Charity – to advise that the saw has been delivered.
 - Weeding/strimming of the area behind the 3 tier planter at Church lane junction. This has not been undertaken, the meeting agreed to ask J Nettleton to undertake this work.

8. Police Matters :

a) Community Speed Watch – M Birtle advised the meeting that a vehicle had been recorded travelling at 103mph by the Brocklesby road speed camera. It is obviously a small minority of drivers who are exceeding the speed limit so dramatically but Police enforcement is required to stop this happening. Cllr Hannigan advised that a meeting has been arranged for 26/6/23 with Ward Councillors, URSG and N.L.C highways officers to discuss the problem of speeding in Ulceby.

There is a possibility that the Police Crime Commissioner is to provide a number of speed sign posts around the county with the speed signs being rotated around these posts. Hopefully Ulceby may be considered for this trial scheme.

b) NATS meeting – Next NATS meeting scheduled for 21/6/23. Cllr Caygill-Ogden will raise the issue of inconsiderate and illegal parking in the village.

9. North Lincolnshire Council Matters:

a) Reports from N.L.C representatives: The consultation on the proposed extension of double yellow lines along Spruce lane to the village hall commences on 22/6/23 for a 3 week period. The parish council and residents can express their views during this consultation process. It is intended that this will also be a 'no Loading' zone – therefore no vehicles can park on these double yellow lines for any period of time. A discussion took place regarding the double yellow lines being extended down Abbey Road – it was agreed that the extension of the double yellows down Abbey Road was not required.

b) Road Safety :

- i. Additional radar speed signs in Ulceby – The clerk has submitted a grant application to the Police and Crime Commissioners fund – the result of this application will be known after the closing date for applications in June.
- ii. Weight Limit for Ulceby and surrounding villages – M Birtle advised the meeting that the Police Crime Commissioner is trying to arrange a meeting with stakeholders to discuss HGV's and the weight limit and associated infringements of this weight limit. Cllr Hannigan advised that he would be attending a meeting regarding the weight limit through Ulceby and would be strongly advising that the weight limit zone is working well.
- iii. HGV's exiting Truck Stop – No further update received. The clerk made contact with ian jickells of N.L.C twice requesting an update on this matter.
- iv. Double yellow lines along Spruce lane to village hall – consultation commences 22/6/23 – see N.L.C representative report.

c) Station Road – land for community garden/allotments: The clerk has been to the solicitors and completed the lease. N.L.C will mow the field on Tuesday – then the parish council will take over responsibility.

d) Footpaths – inspection of throughout the village – Information relating to which footpaths require immediate attention has been submitted to N.L.C. Awaiting their response.
