A meeting of Ulceby Parish Council was held on Monday 18th September 2023 at 7.00pm in the village hall.

PUBLIC FORUM

A member of the public advised the meeting that a petition has successfully been lodged with N.L.C requesting that the parking issues along Abbey Road are resolved. A member of the public brought to the meetings attention the speeding issues in Ulceby and suggested that 20mph zones were considered in the village. The member of the public was advised that N.L.C have some 20mph zones in the county and are waiting to see how effective these zones are before considering further zones. Funding and legislation is an issue in implementing these 20mph zones. It was noted that speed monitoring (golden rivers data) would be required in the first instance to prove that there is a regular speeding problem in the areas where these 20mph zones are requested. A member of the public advised the meeting that he had corresponded with N.L.C on a number of occasions regarding the overgrown hedges on Abbey Road and N.L.C have not done anything about insisting that property owners cut back their hedges from the footpath. Cllr Hannigan agreed to take this matter forward with N.L.C.

5. Clerks Updates:

- Replacement litter bin Abbey Road N.L.C have secured the funding for new bins and a schedule/time scale to replace bins is being confirmed.
- Signs Crossroad reported to N.L.C (numerous times) who have confirmed they will be repaired in due course
- Pavement defects Brocklesby Road work undertaken.
- Dropped curb request either side of entrance to Yarborough Court and pavement repairs in this area – pavement repairs undertaken, no response to dropped curb request.

- Overgrown hedges Abbey Road these overgrown hedges have been reported to N.L.C on numerous occasions Cllr Hannigan agreed to take up with N.L.C.

The accounts were proposed for payment by Cllr C Rowland, seconded by Cllr L Burdin and unanimously agreed.

8. Police Matters:

a) Community Speed Watch – The volunteers for this scheme are still active in the village. S Smith advised the meeting that enforcement from the Police is required to stop the persistent speeding drivers through the village. Data provided by the speed watch team showed that 15-20% of vehicles are speeding when travelling through Ulceby. Cllr Hannigan advised the meeting that Inspector Chad Stephens, who is an advocate of community policing, has agreed to deploy officers to Ulceby when resources allow. b) NATS meeting – No matters to report.

9. North Lincolnshire Council Matters:

a) Reports from N.L.C representatives: Cllr Hannigan advised that he had attended a liaison meeting with Inspector Stephens recently.

b) Road Safety:

- i. Weight Limit for Ulceby and surrounding villages Mr S Smith advised the meeting that he had emailed a number of haulage firms recently advising them that their drivers are travelling through the village unnecessarily all agreed to remind their drivers of the weight limit through the village. Cllr Hannigan advised the meeting that, as yet, there have not been any challenges in the judicial review of the weight limit in Ulceby.
- ii. HGV's exiting Truck Stop Gareth Denovan of N.L.C has advised that he feels the Give Way is quite clear for HGV drivers leaving the truck stop and they have to exit through gates so no drivers are leaving at any speed. The truck stop believes that the HGV drivers are driving appropriately, it is the drivers on the road who are travelling too fast and not reacting to seeing a lorry starting to pull out. G Denovan advises that there are no signs which can be used to warn motorists of the truck stop and advises that he doesn't feel there is anything else to be done.
 - Cllr Hannnigan advised that he would speak to N.L.C officers regarding reviewing the speed limit from the roundabout to the Truck Stop and will also request that the road markings (side of the road) are reinstated.
- iii. Double yellow lines/ No loading restriction/disable parking space (High Street) There have been objections to the disabled parking space, therefore the Director has to consider and make a judgement which will happen in due course.
- c) Station Road land for community garden/allotments: A notice on the Ulceby Parish Council and Ulceby social media pages has been placed asking for people interested in being involved in this project to contact the clerk. There have been 3 or 4 responses from the community. The clerk will arrange a meeting with the landscape gardener and invite all volunteers to attend. Councillors who have asked to be involved in this project are: Cllr's Berney, Hulatt and Macefield.
- d) New matters to report: Cllr Burdin brought to the meetings attention signs which say 'Dress Bright, Be Seen, Share the Road' which she felt might be appropriate for Thornton lane, Cross Road and Brocklesby Road. S Smith suggested that he ask the Safer Roads Humber team if these signs are available in North Lincolnshire.
