A meeting of Ulceby Parish Council was held on Monday 18th March 2024 at 7.00pm in the village hall.

Welcome to representatives of Greystoke Land to discuss a proposed development close to Habrough roundabout.

The representative from Greystoke Land advised the parish council of a proposal to build a large artificial intelligence data centre located off Habrough Road, near the Truckstop roundabout. This will be the first development of this nature in England and it is likely to be a 3 year construction period. There are likely to be approximately 3000 jobs created in the construction period and approximately 370 well paid permanent jobs created once the project is complete. There will be a biodiversity net gain and green houses will be built on site to utilise the waste heat. There is also a possibility of the waste heat being used to heat Immingham swimming pool.

N.L.C have indicated that they are receptive to this development and there is likely to be a considerable S106 contribution to the local area.

When the planning application is submitted and the parish council are considering the Greystoke representative agreed to return to the meeting to ask any further questions.
