A meeting of Ulceby Parish Council was held on 22nd April 2025 at 7.00pm in the village hall.

Welcome to Leo Hammond, Deputy Police and Crime Commissioner for Humberside – Auto Speed Watch presentation.

Leo Hammond explained that the elected role of the Police and Crime Commissioner was to set strategic aims for the police force and to commission services away from the police force such as the community speed watch scheme and auto speed watch. Leo Hammond explained that the auto speed watch scheme will not require volunteers but it is hoped that the community speed watch scheme will work alongside auto speed watch and the auto speed watch scheme has a number plate recognition camera and the evidence from the camera can enforce the contravening of weight limit restrictions, vehicle tax and MOT evasion. These camera's will give the village 24 hour coverage and signs will be displayed advising drivers that they are passing through a speed monitored zone. The evidence will be supplied straight to the ticketing office which will reduce the need for Police involvement. Each camera will cost in the region of £750 of which there is likely to be a grant for 50% with the parish council paying for 50% of the sign cost, appropriate post and installation costs. There is also an annual licence fee cost which will be approximately £200/annum. This scheme is likely to be rolled out at the end of the calendar year when the automation is in place and working effectively.
