

A meeting of Ulceby Parish Council was held on 16th June 2025 at 7.00pm in the village hall.

3.**Adoption of the minutes of the Monthly Parish Council meeting held on 19th May 2025**

IT WAS RESOLVED that the minutes of the monthly parish council meeting held on 19th May 2025 be confirmed as a correct record and signed by the Chairman.

4. Clerks Updates:

- Signs – Crossroad and Thornton lane – all need reinstating. Cllr Wells has taken this up with N.L.C and will report again after this meeting.
- Footpath repairs on High Street – opposite the Chinese takeaway – reported as health and safety concern as the surface is very uneven. Cllr Hannigan has agreed to arrange a site meeting.
- Footpath repairs from the Coronation Road junction to James Place – N.L.C have indicated that this footpath does not meet the required criteria for repair – it will be monitored but no repairs will be undertaken immediately.

IT WAS RESOLVED unanimously to accept the Internal Auditors report and to approve and authorise the signing of i)The Governance statements and ii) The Accounting statements.

The Chairman was authorised to sign the relevant sections of the Annual Return.

- d) To advise that the community grant application for 'In Bloom' has been allocated and Ulceby PC has been awarded up to £400.

7. Police Matters :

- a) NATS meeting – The NATS meeting was held on 4th June 2025 – a full report will be submitted next month.
b) New Police matters to report – No new matters to report.

8. North Lincolnshire Council Matters:

- a) Reports from N.L.C representatives: Cllr Wells advised the meeting that Cllr R Waltham has been appointed chairman to a committee on the Greater Lincolnshire body however no decisions have been made regarding the management of roads and highways in the North Lincolnshire council area. Cllr N Poole has been appointed cabinet member for highways in North Lincolnshire.
Cllr Hannigan responded to the email from the resident regarding the increasing amount of litter in the village, the suggestion that the number of litter and dog waste bins had reduced, that a larger bin is required adjacent the co-op and perhaps signs advising residents to dispose of their litter appropriately. Cllr Hannigan has asked N.L.C head of waste to verify the number of bins in the village and clarify if the number of bins has reduced over the years and to confirm the capacity of the existing bins – this will evidence if further or larger bins are required. Cllr Hannigan advised that he supported a village volunteer litter pick and will supply equipment required.
- b) Community Speed Watch – All community speed watch volunteers have now received the on-line training and Dan Goodwin has been appointed the new speed watch coordinator for North Lincolnshire and a 'TEAMS' meeting will be held shortly. This month the high speed recording on Spruce lane was 69mph with a 16% speed violations recorded and on Brocklesby Road a high speed of 77mph was recorded with a 64% speed violation recorded. July 11th is a national community speed watch day.
- c) Road Safety : The permanent weight limit signs have now been put in place at the Killingholme roundabout. The double yellow lines for Abbey Road and Spruce lane have been marked up and it is anticipated that they will be installed between 18-20th June.
- d) New matters to report: A discussion took place regarding the security of the parish council website and it was agreed to ask the website host to provide a SSL certificate at a cost of approximately £60/annum.

10. Environmental and Village issues

- a) Station Road – land for community garden:
- i) Update on progress made – Cllr Hulatt has spoken to J Nettleton regarding the mowing of the field – he may be able to get someone to bale it and remove the bales. J Nettleton has also indicated that he will be able to rotivate and sow the wild flower seeds with a specialist piece of equipment which he can hire.
 - ii) Community Payback scheme – update on possibility of this scheme assisting on the Station Road field – Cllr Hulatt has spoken to the co-ordinator of the community pay back scheme and hopefully they will be engaged to undertake some work at the Station Road field.
The report/press release from the Humber Forest/Re-Wilding group was approved.

- b) 'Village Clean' project – Cllr Burdin has asked the school to design some posters for the village clean initiative. It was agreed that this village clean would be held over the weekend of 26/7th July. It is intended to repaint the war memorial railings, undertake a litter pick and possibly tidy the village pump area. It was agreed that a budget of £150 could be used for this project and materials to be bought from Barton Builders. The community pay back scheme could also be involved in this project – the contact number for the co-ordinator to be provided to Cllr Burdin.
- c) New village matters: Cllr Burdin advised that a new Royal British Legion representative is required in Ulceby for the forthcoming year.
It was noted that the hedges along West End Road are overgrown and infringing the footpath.
