- b) Community Speed Watch URSG representative advised the meeting that a new on line training system has been rolled out for community speed watch volunteers and a number of members of the Ulceby group have undertaken this training. The group are also intending to undertake this on line training together to ensure they all have the same understanding.

 Spruce Lane recorded a 15% speed violation this month with a high speed recording of 77mph Brocklesby Road recorded a 65% speed violation with a high speed recording of 95mph.

 The speed watch team are having a day of action with the police in the village on July 11th.

- d) Road Safety: URSG representative is meeting with National Highways to discuss the positioning of the weight limit signs at the Truck Stop roundabout the existing signs are temporary.

 URSG representative asked if the parish council had been given an update on the TRO(double yellow lines) from Abdals restaurant to the village hall and also along Abbey Road. No update has been received.

10. Environmental and Village issues

- a) Station Road Mrs Phillips attended the meeting to report for the volunteer group on this project. Two trees have not survived in the orchard plantation but others are growing and blossoming well. 50 trees within the Humber Forest planting have not survived but will be replaced in due course. The group have been successful in securing 270 mixed trees which will be planted in November by volunteers. Tree protectors are kindly being provided by a resident FOC, stakes and cable ties may need to be purchased. The planting of these woodland trust trees will need to be advertised and hopefully volunteers will come forward to help plant. 4Kg of wild flower seed has been purchased and will be planted in the autumn. The ground needs preparing for the planting of the seeds and a local man has been approached and he has kindly volunteered to prepare the ground. The PC is extremely grateful for this kind offer of help. Donations amounting to £200 have been given by 2 residents towards the cost of the wild flower seeds for which the parish council again, is extremely grateful. It was noted that some mowing is required and it was agreed to ask J Nettleton to undertake this work clerk to ask Cllr S Hulatt to liaise with J Nettleton for the areas/pathways which need mowing. A resident has offered a number of plants from her garden for the project Cllr Hulatt will make arrangements for these plants to be transferred at the right time.
- b) To discuss the possibility of a village clean and make arrangements to promote/advertise It was agreed that the village pump area would be tidied up as part of the village clean initiative along with the repainting of the war memorial railings by volunteers. Cllr Burdin will advertise the war memorial fence painting initiative on social media asking for volunteers brushes/paint will be purchased by the parish council.
- c) New village matters: The hedge adjacent the co-op store, near the tiered planter and seat is badly overgrown and infringing the pavement. It was reported that a car is constantly parking on the grass verge opposite the old Chapel on Coronation Road which has badly damaged the grass verge.
