3. **Adoption of the minutes of the Monthly Parish Council meeting held on 20th October 2025**

IT WAS RESOLVED that the minutes of the monthly parish council meeting held on 20th October 2025 be confirmed as a correct record and signed by the Chairman.

4. **Clerks Updates:**

- UKSPF grant – Clerk has submitted a revised application for picnic table benches and seating.
- Public Footpath sign near school – Cllr Burdin will check if this sign is in place or needs to replacing/fixing.

5. **Planning Applications** - Opportunity for one person from each side (members of the public to state within three minutes objections/support of contested applications).

A discussion took place regarding the application for lawful development at Abdals restaurant. This application seeks to confirm that there are permitted development rights for this property. N.L.C will make a decision on this matter – if permitted development rights are valid, planning permission is not required.

7. **Police Matters :**

a) NATS meeting –The next NATS meeting is scheduled for Wednesday 19th November in South Killingholme village hall.

b) New Police matters to report – No new matters to report.

8. North Lincolnshire Council Matters:

- a) Reports from N.L.C representatives: Cllr Hannigan provided an update on the College Road closure (due to badgers) – It is believed that the badgers have migrated – if this remains the case for 21 days then work can commence and the project is likely to take about a year. Ward Councillors are putting pressure on N.L.C to speed this repair up – URSG representative advised that traffic through the village (since the College road closure) has increased from 720 vehicles per day to 1500 vehicles per day.
- b) Community Speed Watch – URSG representative advised that the speed watch group would be active in Ulceby this week and the latest speed data showed a high speed of 84mph on Spruce Lane and 104mph on Brocklesby Road. The Police have confirmed that they will carry out further monitoring in the village in relation to the weight restriction and speed of vehicles.
- c) Road Safety : Leo Hammond has not responded to the request for information relating to the availability of the new speed monitoring signs. The URSG representative advised that the Charity BRAKE has reported a 21.7% increase in road fatalities or injuries in North Lincolnshire since 2023.
- d) New matters to report: No new matters to report.

10. Environmental and Village issues

- a) Station Road – land for community garden:
 - i) Update on progress made – Plants, bulbs, herbs etc have all been planted. Further trees have also been planted but tree ties are required and will be fixed this week. The seating areas have been marked out and the trees planted around these areas this week. Humber Forest and Youth Re-wilding have revisited the site and have noticed that some of their trees have been caught with the trimmer – they have advised that they will look after the areas of the community garden they took responsibility for and planted. There is a large pile of debris/branches/trimmings that need removing from the site – it was suggested that J Nettleton might chop these branches and can be used for pathways etc.
- b) New village matters:
 - i) To agree the purchase of and set a budget for the purchase of a Christmas tree for the village.
IT WAS RESOLVED to authorise the purchase of a tree to be situated at the war memorial.
 - ii) New village matters – Cllr Burdin advised that approximately 500 bulbs have been planted down West End road by school children and resident volunteers.
Cllr Hannigan advised that N.L.C have no plans to repair/resurface/realign the footpath along High Street – opposite the Chinese.
The playing field will receive one more cut this year.
The lamp post poppies will be removed at the end of the month.
The over 60's Xmas party – closing date, this Friday 21st November.
